Information about the incident

I AM A CREDENTIALED CHICAGO JOURNALIST AND A JOURNALISM PROFESSOR AT LOYOLA UNIVERSITY. A CHICAGO POLICE OFFICER ILLEGALLY ERASED MY VIDEO FILES. THIS ACT IS NOT ONLY ILLEGAL, BUT UNCONSTITUTIONAL. IN ADDITION TO THIS COMPLAINT, IT IS MY INTENTION TO SEEK CIVIL LEGAL ACTION. AT ABOUT 9:00 P.M. ON SATURDAY, NOVEMBER 12, 2011, I WAS IN THE RED LINE SUBWAY STOP AT CHICAGO AND STATE STREET VIDEOTAPING TWO PLAIN CLOTHES CTA POLICE OFFICERS ARREST A YOUNG BLACK MALE FOR JUMPING THE TURNSTILE. IT WAS A TEXTBOOK ARREST, VERY PROFESSIONAL. ABSOLUTELY BY THE BOOK. HOWEVER, WHEN ONE OF THE OFFICERS SAW ME VIDEOTAPING (I WAS ABOUT 40 FEET AWAY ON THE OTHER SIDE OF THE TURNSTILE, IF YOU ARE FACING THE SUBWAY OFFICE IN THE MIDDLE OF THE TURNSTILES, I WAS 10 FEET TO THE LEFT AND CLOSE TO THE WALL) THE OFFICER APPROACHED ME AND TOLD ME TO TURN OFF THE CAMERA. HE GRABBED BY RIGHT ARM AND TWISTED IT BEHIND MY BACK (AGAIN, TEXT BOOK ARREST, NO REAL PAIN). I IDENTIFIED MYSELF AS A JOURNALIST, LASKED WHY I WAS HANDCUFFED AND HE SAID I WAS OBSTRUCTING AN INVESTIGATION. I WAS TAKEN TO THE SQUAD CAR IN CUFFS WHICH WAS PARKED ON NORTH STATE STREET 40 FEET FROM CHICAGO AVENUE. I REMAINED CUFFED IN THE BACK SEAT OF THE POLICE CAR FOR ABOUT 20 MINUTES WHILE THEY SEARCHED AND TALKED TO THE YOUNG MAN THEY ARRESTED, AT WHICH POINT. THE POLICE OFFICER WHO PUT IN HANDCUFFS GOT IN THE DRIVER'S SEAT AND PROCEEDED TO ASK ME QUESTIONS REGARDING MY PURPOSE IN VIDEOTAPING AND HE EXPRESSED HIS STRONG FEELINGS THAT IT WAS ILLEGAL TO VIDEOTAPE POLICE DURING AN ARREST, AFTER CHECKING MY NAME FOR A POSSIBLE RECORD, I WAS LET OUT OF THE POLICE CAR AND THE HANDCUFFS WERE REMOVED. AGAIN, THIS ACTION WAS BY THE BOOK AND ABSOLUTELY PROFESSIONAL. AT THAT POINT, THE POLICE OFFICER WHO HANDCUFFED ME ASKED FOR MY KODAK FLIP CAMERA. HE FOUND THE CLIP OF THE ARREST AND ERASED IT. THIS WAS WITNESSED BY HIS PARTNER AND MYSELF. THE CTA
